TERMS AND CONDITIONS

1. This form is to be filled in by the applicant and returned to Aerial Capital Group Ltd by fax or email..
2. Please note that all requests for transportation will be attempted, but cannot be guaranteed.
3. Aerial will grant credit and trading terms on the following basis:
 - All invoices will be payable 7 days from the invoice date and will include an account keeping fee of 5% plus GST. A discount of 5% is available if the payment is received within this period.
 - For payments received between day 8 and day 21 of the invoice date, the account fee of 5% plus GST is payable.
 - If payment is received after day 21 the account keeping fee plus interest at 15%pa will apply. Interest will be charged from day 22 until receipt of payment.
 - All payments received will be credited against the oldest amount shown on the customer statement.
 - Clients who have provided credit card details will have payments processed 7 days after the invoice date.
 - AMEX and Diners will incur an additional surcharge of 3% plus GST.
4. All 'No Contact' account bookings will incur a fee:
 - \$8.60 incl GST for Canberra Elite and Silver Service taxis
 - \$65 incl GST for Canberra Hire Cars
 - BUSme will incur the fee of the full quoted amount
