## WANT TO JOIN OUR TEAM AS A DRIVER

1. Must have a full Australian Driver's License

2. In Canberra you need to go to Access Canberra to get a T endorsement on your ACT license, need to apply for a WWVP card and a driver authority card. There is a small cost in getting these cards. Keep your receipts for taxation claims.

This also applies if you come from another state or country.

3. If you live in NSW, then the process is the same, but you must go to NSW RMS. You must also produce your passport if you are from another country.

4. You must go to the ATO or post office to apply for an ABN Number.

5. You must do at least 15 hours of Jockeying in a taxi with an approved operator, learn and understand the MTI Dispatch system and the PAX payment system and the Shadow Meter. There is a jockeying form to be filled in by your operator that you have the knowledge and confidence in driving a taxi.

There is a short training video that you will need to view as you will be asked questions when you come to the base with your paperwork. This also includes Guide dogs, companion animals, working with the elderly and frail.

6. Once you have completed the above sections and complete the "NEW Driver Form" then bring everything to the base where you will be given a PIN Number so you can access the dispatch system. You will be required to complete all attached paperwork.

**This PIN Number is NOT to be shared with anyone.**

7. Taxi uniforms are available at the base. You should keep the receipt and claim them on your taxation

8. To be part of our Silver Service Team you will require a clean driving record for more than 12 months.

9. **ALL** drivers are answerable to their operators, and **ALL** operators are answerable to Aerial Capital Group administration
